As per the paper read as (3) the Secretary, Bar Council of India has informed that the Standing Committee (Sub Committee) of the Legal Education Committee of the Bar Council of India at its meeting held on 16th July, 2017 considered the letter read as para(2), since the University has deposited ₹ 2 lakh towards default money in respect of five year course specially for the batch of 2011, who have passed out. Accordingly their degree for BA LLB stands regularized and hence such students who have passed would be entitled to be enrolled as advocates by the State Bar Council subject to other conditions. Based on the above decision taken by the Bar Council of India, the 2011 batch admission of the course stands regularized.
