ORDER

The Academic Council held on 24.10.2016 vide its Minutes Item No.70/Ac.15/16301 constituted a committee with Dr. A. Praveen, Dean, Faculty of Engineering & Technology, Dr. Bindu V.R., Dean, Faculty of Technology & Applied Sciences and Prof. (Dr) M. S. Latha, Dean, Faculty of Science as members to study the B. Tech Regulations and to submit a report on the possibilities of allowing students to re-do their internal examinations and decision on B.Tech class average based on Interim Court Order. Accordingly the Committee was constituted vide U.O. read as paper (1). The Committee in turn has submitted its report before the Standing Committee of the Academic Council held on 25.09.2017. A University Order read as paper (3) issued on re-do of internal examinations. The recommendations of the committee on class average of internal marks of VIII Semester based on Interim Court Order are as follows:

- "(1) To proceed with the verification of the internal marks of all the students including the petitioners as if they were regular VIII Semester students.
 - (2) To ignore the variation of average percentage of marks of the students as, exceptional case, if orders of the Hon'ble High Court compel to cancel the internal marks of a few students."

Vide the paper read as (2) above, the Standing Committee on Academic Council had resolved to recommend to approve the above report.

The Vice-Chancellor has approved the recommendation of the Standing Committee of the Academic Council exercising powers conferred upon him as per Section 10(17)Chapter 3 of Mahatma Gandhi University Act 1985.
