ORDER

As per the letter read 1 above the secretary, University Grants Commission has informed that the UGC had come up with an Approved List of Journals that would be considered for the purpose of Career Advancement Scheme (CAS) and Direct Recruitment of Teachers and other Academic Staff as required under the UGC Regulation. It was also informed that Universities may also recommend inclusion of additional peer-reviewed Journals that are not available in the existing list of approved Journals and for this Universities are required to appoint an Academic Journal Expert Committee at University-level with a Senior Professor, Associate Professor as its Chairman.

The matter was considered by the Standing Committee of the Academic Council at its Meeting held on 13.07.2017 and resolved vide ref.2 above to recommend to constitute the University level Academic Journal Expert Committee with Dr. A. M. Thomas, Dean Faculty of Social Science as its Convener and Dr. M. S. Latha, Dean Faculty of Science, Dr. P. S. Sukumaran, Dean Faculty of Behavioural Science and Dr. P. S. Radhakrishnan, Dean, Faculty of Language and Literature as members of the committee.

The recommendation of the Standing committee was considered by the Vice-Chancellor and has approved the same renaming the committee as 'Academic Journal Expert Committee' and its Convener as Chairman by exercising power under Section 10 (17) of Chapter 3, of Mahatma Gandhi University Act 1985.

Orders are issued accordingly.
