Vide the paper read as (1) above, a student of the B.Tech course shall be permitted to appear for the semester end examination only if he/she satisfies the following requirements:

(a) He/She must secure not less than 75% attendance in the total number of working periods during the first year and in each semester thereafter, and shall be physically present for a minimum of 60% of the total working periods. In addition he/she also shall be physically present for a minimum of 60% of the total working periods. In addition he/she also shall be physically present in at least 20% of total attendance for each subject.

Vice-Chancellor shall grant condonation of shortage of attendance upto 10% on the recommendation of the Head of the institution for medical ground only.

The meeting of the Standing Committee of Academic Council held on 07/12/2017 vide the paper read as (2) recommended to lower the limit of condonation of shortage of attendance to 55% for 7th Semester B.Tech course students for registration of 7th Semester examination and to promote them to the 8th Semester, granting notional registration.


