ORDER

As per B.Tech regulations prevailing from 2010 admission onwards “for Seminar, Project and Viva-Voce (in 8th Semester) the minimum for a pass shall be 50% of the total marks assigned to the respective examination.” Vide paper (1) above since seminar and project in the 7th and 8th semesters are having purely internal evaluation if the candidate has not secured the pass minimum he/she should repeat the respective semesters in total. This case is applicable to all subjects with only internal evaluation.

After a detailed discussion on a request of a B.Tech student to repeat his seminar of the VII Semester, the Board of Studies in Engineering (U.G) vide the paper read as (2) recommended not to change the existing regulation/recommendation of the meeting of the last Board of Studies.

Two students of Musaliar College of Engineering were exempted from repeating the 7th Semester of B.Tech course and vide the paper (3) above granted permission to present their 7th semester seminar for a second time as they had already completed the course.

Vide the papers read as (5) and (6), taking into consideration of the ongoing disaffiliation, the option for re-doing the internal assessment part of failed theory papers of B.Tech course has been allowed to all of the B.Tech students (2010 admission onwards) who already secured 40 percent of marks or above in the University Theory

Examinations and had completed their 4 years of B.Tech study. The meeting of the Standing Committee of Academic Council held on 07/12/2017 vide the paper read as (7) recommended to extent the provision of internal redo for theory papers as stipulated in the papers read as (5) and (6) to practical, project, seminar and workshop of the B.Tech programme also. Moreover, it was also recommended to grant relaxation to the condition to repeat the whole 8th semester if failed in project or seminar by allowing such students to appear for the supplementary examination of the failed subjects only.

The B.Tech course has been disaffiliated from this University in a phased manner with effect from 2015 onwards and only 8th semester is ongoing under this University at present. Considering the emergency of the case the Vice-Chancellor has approved the above two recommendations of the Standing Committee of the Academic Council, exercising powers conferred upon him as per Section 10(17) Chapter 3 of Mahatma Gandhi University Act 1985.

The Regulations of the B.Tech course (2010 admission) stands modified partially to the above extent.


