ORDER

Clause 15 of the B.Tech regulation prevailing from 2010 admission onwards is given below.

15. Eligibility for promotion to Higher Semester – Procedure for completing the course.

(a) A student who has secured 75% of the attendance and has exhibited satisfactory progress in the class will be eligible for promotion to the next higher semester.

(b) However, before being admitted to the VIII semester classes, the student should have passed in all subjects in the combined first and second semester examination in full.

As per the U.O's read (2), (3) & (4) above, the B.Tech students of 2010, 2011, 2012 and 2013 admissions were exempted from passing I & II semester examinations for promotion to the VIII semester in relaxation of clause 15(b) of the B.Tech regulations.

The meeting of the Standing Committee of the Academic Council held on 30/04/2018 vide paper (5) above recommended to extend the benefit of the U.O's read above to the B.Tech students of 2014 admission batch also.

Orders are issued accordingly.


