പരാമർശം(1) പ്രകാരം ബിരുദ പ്രോഗ്രാമുകളുടെ (CBCS 2017) പുതുക്കിയ റഗുലേഷൻ, സ്കീം, സിലബസ്, പാഠപുസ്തകങ്ങൾ എന്നിവ അക്കാദമിക് കൗൺസിൽ അംഗീകരിച്ച് ഉത്തരവായിട്ടുണ്ട്.

പരാമർശം(2) പ്രകാരം ബിരുദ പ്രോഗ്രാമുകളുടെ ഭാഷാ പാഠപുസ്തകങ്ങളുടെ (മലയാളം, ഹിന്ദി, ഇംഗ്ലീഷ്) പ്രസിദ്ധീകരണത്തിനായി പ്രിൻറിംഗ് ആൻഡ് പബ്ലിഷിംഗ് ഡയറക്ടറുടെ ചുമതല വഹിക്കുന്ന അദ്ധ്യാപകൻ കൺവീനറായി, ജോയിൻറ് രജിസ്ട്രാർ I (ഭരണവിഭാഗം), ജോയിൻറ് രജിസ്ട്രാർ II (ഭരണവിഭാഗം), ജോയിൻറ് രജിസ്ട്രാർ (സാമ്പത്തികം) എന്നിവരുടേതായ ഒരു സമിതിയെ നിയോഗിച്ചിട്ടുണ്ട്.

ബിരുദ പ്രോഗ്രാമുകളുടെ മൂന്നാം സെമസ്റ്റർ ഭാഷാ പാഠപുസ്തകങ്ങളുടെ (മലയാളം, ഹിന്ദി, ഇംഗ്ലീഷ്) പ്രസിദ്ധീകരണം സംബന്ധിച്ച് മേൽ സമിതി 27/04/2018 ൽ യോഗം ചേർന്ന് പരാമർശം(3) പ്രകാരം താഴെപ്പറയുന്ന ശിപാർശകൾ നൽകുകയുണ്ടായി.

I. The committee discussed the urgency of printing and publication of Malayalam, English and Hindi textbooks of III semester UG Programmes of CBCS regulation 2017 and considered the willingness of various printers to work as co-publishers. On the basis of the above, it was resolved to recommend to entrust the following publishers with the printing and publication of Malayalam, English and Hindi text books of above semester under co – publication with the University as per the specifications and terms and conditions as detailed below.

II. It was also resolved to recommend incorporating the following terms and conditions in the MOU to be signed between university as the Publisher and the above printers as co-publishers.

1. Statement of specifications (Annexure- I) for printing of the books (No. of copies printed, quality of paper used for text, card used for cover, type of printing as to whether multi colour or single colour and type of binding) shall form part of this agreement.
2. The CO-PUBLISHER will supply the manuscripts of the material to the PUBLISHER for editing and production. The PUBLISHER will supply the edited, full and final manuscripts to the CO-PUBLISHER for printing.
3. Before the final printing of the book the CO-PUBLISHER will take the approval of the PUBLISHER for the text, preliminary pages and the cover.
4. The CO-PUBLISHER undertakes that information in the book has been obtained from sources believed to be reliable and is correct to the best of their knowledge.

5. The PUBLISHER shall in no event be liable for any errors, omissions, disputes on intellectual property, or any damages or loss whatsoever manner caused to any person, whether the purchaser of the book or not and disclaim any implied warranty or fitness for any particular use.
6. The CO-PUBLISHER will at their own cost arrange to clear the copyright for the pieces to be included in the book for which permission is required.
7. The CO-PUBLISHER will produce the book at their own cost (cost of production i.e. Printing of book, cover design, binding etc.) within 60 days from the date of supply of the typescripts.
8. The published book will carry the imprints of the PUBLISHER and the CO-PUBLISHER.
9. a. The copyright of the materials will rest with the CO-PUBLISHER.
b. The co-publishing right of the book will jointly rest with the PUBLISHER and the CO-PUBLISHER.
10. The published price and print run of the book will be mutually agreed by the PUBLISHER and the CO-PUBLISHER
11. The CO-PUBLISHER will undertake the marketing and distribution of the books. The CO-PUBLISHER will also be free to sell the books outside Kerala State.
12. The CO-PUBLISHER will be responsible for taking delivery of the printed books from the printer's premises.
13. The CO-PUBLISHER or their permitted assignees or agents will not revise, copy or reproduce this book in any form whatsoever, or translate in other languages this book without prior approval of the PUBLISHER.
14. Every new impression/edition/revision will be prepared by the CO-PUBLISHER with the prior concurrence of the PUBLISHER
15. Should it be necessary to increase prices of subsequent editions because of increase in cost of production, the CO-PUBLISHER will obtain permission from the PUBLISHER before doing so.
16. The CO-PUBLISHER shall give 12 copies of each book free of charge to the PUBLISHER and 5 copies to the respective contributor (writer/legal heir) and the same hold good for subsequent editions.
17. The CO-PUBLISHER shall pay an advance royalty of Rs.2000/- (Rupees Two thousand only) which will be adjusted against the future royalty statements. The payment shall be made by Demand Draft drawn in favour of the Director, Department of Printing and Publishing, Mahatma Gandhi University and payable at State Bank of India, M.G. University Campus Branch.
18. The CO-PUBLISHER shall make half yearly statement of sales by 31st of March and 30th September and shall pay a royalty @ 12.5% of the published price on all copies sold, to the PUBLISHER by way of Demand Draft drawn in favour of The Director, Department of Printing and Publishing, Mahatma Gandhi University payable at State Bank of India, M.G. University Campus Branch not later than the date of sales statement. The CO-PUBLISHER is responsible to give sale statement to the PUBLISHER at any time.
19. The CO-PUBLISHER shall handover 50 copies of books to the PUBLISHER for sale or return basis. The PUBLISHER shall prepare annual statement of sales of books by 31st March and hand over the same to the CO-PUBLISHER along with the amount due after deducting trade discount by way of Demand Draft before 31st May of every year.
20. The CO-PUBLISHER will not produce or draw agreements with other publishers to produce titles similar to the book.
21. The rights of the CO-PUBLISHER under this agreement shall not be assigned in any manner without the written permission of the PUBLISHER.
22. It is agreed by the PUBLISHER that if any dispute arises touching this agreement, only courts at Kottayam shall have the jurisdiction.

23. The agreement shall be valid till all the copies of this book are exhausted or for 5 years whichever comes earlier
24. If the CO-PUBLISHER violates any condition of the agreement, the PUBLISHER has the right to cancel the agreement at any time.

III. The Committee also resolved to recommend to incorporate in the agreement with Malayalam co-publisher the provisions of Cl.6 and 9(a) amended as follows:

Cl. 6. The PUBLISHER will take steps to clear the copyright of the pieces to be included in the book obtaining permission from the authors/ copyright holders and the remuneration payable to them will be paid by the CO-PUBLISHER to the publisher for payment directly to the authors / copyright holders.

Cl. 9(a). The copyright of the materials will rest with The PUBLISHER.


