ORDER

In exercise of the powers conferred by Section 12(1) of Chapter III of Mahatma Gandhi University Act 1985, the Syndicate at its meeting held on 15.02.2020 vide paper read (3) above resolved to appoint Dr. Prakash Kumar B. Blue Bell Apartments, Block 2, A 2, Kalthilpady, Vadavathoor -68610 (Professor, School of Bio-sciences, Mahatma Gandhi University) as Registrar of the University with immediate effect on deputation basis for a period of four years from the date on which the incumbent assumes office or till he completes the age of of Fifty Six years whichever is earlier, and on such terms and conditions as may be prescribed by the statutes. Accordingly U.O. read (4) and appointment letter read as (5) were issued.

Dr. Parakash Kumar B. was relieved of his duties as Professor, School of Bio-sciences and from the charge of Controller of Examinations with the effect from the A.N. of 15.02.2020 vide paper read as (6), to take up appointment as the Registrar of Mahatma Gandhi University.

As per paper read as (7) above, Dr. Prakash Kumar B. reported to join duty before the Vice Chancellor on 15.02.2020 A .N .

Sanction has, therefore, been accorded by the Hon'ble Vice Chancellor to Dr. Prakash Kumar B., Blue Bell Apartments, Block 2, A 2, Kalthilpady, Vadavathoor -68610 (Professor, School of Bio-sciences) being appointed as Registrar of Mahatma Gandhi University w.e.f.15.02.2020 A.N. on deputation basis for a period of four years from the date on which he assumed office or till he completes the age of of Fifty Six years whichever is earlier, and on such terms and conditions as may be prescribed by the statutes in the pay applicable to Academic level 14 (Rationalised Entry Pay Rs.1,44,200) of VII UGC Scheme.

He is permitted to carry on Research work in School of Bio-sciences.
