Read:-Minutes of the meeting of the Board of studies held on 18/09/2021 submitted by the Chairperson.

<u>ORDER</u>

The Board of studies B Arch (UG/PG combined) of the University in its meeting held on 18/09/21 discussed various matters including the conduct of various UG/PG examinations, Question bank preparation(new scheme),Paper valuation of previously conducted examinations,Swapping of 9th Semester instead of 7th semester for the 2018 Admission B Arch batch,conduct of Thesis Jury of 2016 admission batch,etc and the following recommendations were submitted vide reference cited.

1. Announcement for S3 examination (2019 scheme) :

Notification for S3 examination (2019 scheme)) has to be given at the earliest.

2. Question bank preparation for S4 examination (2019 scheme)

Question bank preparation for S4 (2019 scheme) has to begin immediately, to avoid any further delay for examination. Notification for the same has to be issued at the earliest.

- 3. Paper valuation of previously conducted examinations
 - Paper valuation for previously conducted S1 & S2 examination (2019 scheme) has to begin immediately, without which examination cannot be conducted for the present S1 & S2 batch (2020-25).
 - Paper valuation for previously conducted S6 examination (2011 scheme) has to begin immediately, without which examination cannot be conducted for the present S6 batch (2018-23).
 - Paper valuation for previously conducted S4 examination (2011 scheme) has to begin immediately, in order to conduct the supplementary examination for the same.
 - S9 examination results will have to be published at the earliest as students have to apply for their Masters or job.

4. Notification for Swapping of Semester S9 instead of S7.

The present S6 batch (2018-23) may be permitted to commence their S9 classes instead of Practical training and Dissertation. Their Practical training & dissertation may be permitted to be done on completion of the S7 swapped classes. Notification for swapping has to be issued at the

earliest in the context of the present Covid-19 situation as was done for the previous batch.

5. Regarding Thesis jury

Thesis students (batch 16-21) had started their thesis with effect from 3rd May 2021 and final jury can be conducted during the first week of December 2021.

6. Examinations of M. Arch Landscape architecture:

The semester examinations of M.Arch Landscape architecture 2019 admission and 2020 admission have not been conducted. Notification has to be published regarding this at the earliest.

The Vice-Chancellor, has approved the above minutes. The recommendation of the Board for swapping of Semester 9 instead of Semester 7 for the present Semester 6 batch (thereby permitting the conduct of Practical Training & Dissertation afterwards as was done for the previous batch) has been approved in exercise of powers under Chapter III,10 (17) of MG University Act,1985.
