Vide read (1) above, Dr. Sajimon Abraham (Honorary Director, UCIC) has requested for some modification in the University Order read (2) above and the Vice Chancellor has issued orders for the modification of the same as follows.

During a collaboration discussion between Mahatma Gandhi University and Taylor's University, Malaysia., both the institutions mutually agreed to sign a Memorandum of Understanding (MoU) and Dr. Sajimon Abraham (Honorary Director, UCIC, Mahatma Gandhi University) vide reference (3) above has forwarded the Draft MoU and the minutes of the meeting between officials of both the universities to discuss the various possibilities of establishing an MoU for the consideration by the Hon'ble Vice Chancellor.

The Legal Advisor of this university has opined that 'signing MoU with Taylor's University is purely a matter of discretion of the Mahatma Gandhi University and if the University is satisfied about the reputation and credibility of Taylor's University as well as the needfulness of the cooperation and collaboration, there is no legal hurdle in signing an MoU'.

Considering the above circumstances and urgency of the proposal, the Hon'ble Vice Chancellor approved the proposal to sign a Memorandum of Understanding (MoU) for Academic Collaboration between Mahatma Gandhi University and Taylor's University, Malaysia., and orders issued exercising powers under Chapter 3, Section 10 (17) of Mahatma Gandhi University Act 1985.
