ADMISSION TO FULL - FLEDGED ONLINE DEGREE PROGRAMMES 2022 WITH GLOBAL INTAKE

Online applications are invited for admission to the UGC entitled full fledged Online Post Graduate Degree Programme - Master of Commerce (M. Com.) Finance and Taxation - conducted by Centre for Online Education, Mahatma Gandhi University. The admission is open to Indian as well as International students. There shall be no age limit and seat limit. Successful completion of this programme will lead to the award of a degree which is equivalent to a conventional regular Degree awarded by this University. Classes will be made available as recorded videos, live discussion forums and e-study materials through Learning Management System which is convenient for working professionals, people who are not able to join regular degree programmes like people with special needs, people who like to acquire additional degrees and other knowledge seekers etc. The examinations will be held in remote proctored online mode which is convenient to all the takers from different geographical regions. The Candidates can apply for the programme online through the website www.mguonline.ac. Online application facility will be opened on 14.03.2022 and closed on 31.03.2022 (11.59 pm IST).

Course Duration: 2 Years (4 Semesters)

Eligibility: A candidate who has passed B Com/BBA/ BBM/Equivalent programmes approved by Mahatma Gandhi University with a minimum of 45% are eligible to pursue the UGC entitled full fledged Online M. Com Programme. The candidates who are expecting to pass qualifying degree on or before 10/04/2022 also shall apply. Relaxation in percentage is allowed for SC/ST, OEC, SEBC and Physically challenged students as prescribed by the University from time to time.
