The Director, School of Chemical Sciences vide paper read (2) requested to renew the Annual Maintenance Contract (AMC) with M/s. Perkin Elmer (India) Pvt. Ltd. Chennai, the Authorised Service Representative of the equipment for a period of one year at a total cost of Rs. 2,75,430/-

The Finance Wing of the University examined the proposal and concurred with the renewal of the AMC proposed.

Sanction has, therefore, been accorded by the Hon. Vice Chancellor to:

1. entrust the Director, School of Chemical Sciences to renew the Annual Maintenance Contract (AMC) with M/s. Perkin Elmer (India) Pvt. Ltd. Chennai, the Authorised Service Representative, for the equipment TG-GC-MS installed in the Department at a total cost of Rs. 2,75,430/- (Rupees Two Lakh Seventy-five Thousand Four Hundred and Thirty only) including taxes, for a period of one year from the date of signing the agreement,
2. pay the total cost of the AMC in two equal instalments to the firm concerned - that is, to pay 50% of the AMC charges after signing the Agreement and the balance amount after the satisfactory maintenance of the equipment for one year by the firm,
3. deduct the TDS applicable and remit it to the Department of Income Tax and
4. debit the expenditure to the Head of Account ' '22 301 45 - AMC for Instruments and Computers ' in the Budget Estimates for the year 2022-2023.
