## **NOTIFICATION**

As per UO cited above (Ref: 2) the fees notification for VI semester CBCSS (2013 to 2016 Admission Mercy Chance) & VI semester CBCSS Cyber Forensic (2017 & 2018 Admission Reappearance/ 2014 to 2016 Admission Mercy Chance) undergraduate examinations (Ref: 1) is modified as follows:

- 1. The examinations for the 2013 admission students are considered as their final mercy chance.
- 2. The examinations for the **2014**, **2015** & **2016** admissions students are considered as their first mercy chance.

The Candidates who are availing first mercy chance (2016, 2015 & 2014 admissions) shall remit a sum of \$5,795/- (Rupees Five Thousand Seven Hundred Ninety Five) and candidates who are availing final mercy chance (2013 admission) shall remit a sum of \$11,580/- (Rupees Eleven Thousand Five Hundred Eighty) as mercy chance fee in addition to the examination fee and C.V Camp fee.

The Last date for submission of application in University Office with a superfine of ₹1225/- is extended to **31.05.2024.** The application form can be downloaded from the official website of the university .Candidates shall remit the fees through MGU Electronic Payment (epay.mgu.ac.in) and submit their applications in the university office .The last date stipulated above are not only for the remittance of examination fee but for the receipt of applications in the university office. Applications received after the last dates will be summarily rejected .

The candidates who had already remitted the fees for VI semester CBCSS (2013 to 2016 Admission Mercy Chance) & VI semester CBCSS Cyber Forensic (2017 & 2018 Admission Reappearance/ 2014 to 2016 Admission Mercy Chance) undergraduate examinations as per the Notification Ref. 1 need not remit fee again.

The date of commencement of examination and detailed time table shall be announced later.
