**ORDER**

The Mahatma Gandhi University Under Graduate Programmes (Honours) Regulations, 2024, MGU - UGP (Honours) have been approved, vide paper read as (1) above, for the commencement of Four Year Under Graduate Programmes from the academic year 2024 - 2025 in the affiliated colleges of the university in accordance with the guidelines of UGC and KSHEC.

Among the various committees constituted for the smooth implementation of the Four Year Under Graduate Programmes, the Subcommittee on Rules and Regulations after detailed deliberations, submitted recommendations to amend the MGU - UGP (Honours) Regulations, 2024 and were placed before the Academic Council for consideration. The Academic Council of the University at its meeting held on 23.05.2024 resolved to approve the recommendations and University Order, vide paper read as (2) above, has been issued.

Later, the Subcommittee on Rules and Regulations has pointed out the need to amend Clause 4, sub -clause xxvi of the MGU - UGP (Honours) Regulations, 2024 and thereforth submitted the following recommendation, vide paper read as (3) above,

"Clause 4. Features and Objectives of MGU-UGP, sub -clause xxvi : **Minor Courses can be selected from any discipline other than that of the Major discipline.**"

Hence, considering the emergency, sanction has been accorded by the Hon'ble Vice Chancellor, in exercise of the Powers of the Academic Council vested upon him under section 10(17), Chapter III

of the Mahatma Gandhi University Act 1985, vide paper read as (4) above, to approve the recommendation for amendment.
