## <u>ORDER</u>

The University Grants Commission vide the letter read above, issued the following Guidelines regarding the refund policy to be adopted on account of cancellation of admission/migration of students after getting admitted to the any admission during the academic year 2024-'25.

1. Notwithstanding anything contained in any Guidelines/ Prospectus/ Notifications / schedule a full refund of fees shall be made by the HEIs on account of all cancellations of admission/ migration of students up to **30 September 2024** and with a deduction of not more than Rs= 1000/- as a processing fee up to **31 October 2024**.

2. It shall apply to all Higher educational institutions whether established or incorporated by or under a Central Act or a State Act and every institution recognised by the University Grants Commission under clause (f) of section 2 of the UGC Act 1956 and to all institutions deemed to be a University declared as such under Section 3 therein and to all higher education institutions affiliated to University.

3. For any admission schedule extending commencing **beyond** *I* **after 31 October 2024**, the provisions contained in the UGC Notification issued in October 2018 on Refund of Fees and Non-Retention of original Certificates shall apply (reproduced below for ready reference.

Category	<b>u</b>	Point of time when notice of withdrawal of admission is received in the HEI
1	100%	15 days or more <b>before</b> the formally notified last date of admission
2	90%	Less than 15 days <b>before</b> the formally notified last date of admission
3	80%	15 days or less <b>after</b> the formally notified last date of admission
4	50%	30 days or less, but more than 15 days <b>after</b> formally notified last date of admission

5	00%	More than 30 days <b>after</b> formally notified last
