As per the paper read (2) above, the Meeting of the Syndicate held on 21.02.2025, considered the matter and resolved to sign the Memorandum of Understanding (MoU) between State Medicinal Plants Board, Kerala and Mahatma Gandhi University, Kottayam for implementing "School Herbal Garden Project", on condition that there shall not be any financial liability to the University and to direct the Coordinator, National Institute of Plant Science Technology (NIPST) to strictly follow the provisions in the MoU as there is a provision that if institution commits breach of any condition in the MoU, the entire money spent shall be refunded to the funding agency.
