The cover containing the quotation should be superscribed "Quotation for the Supply of Reagents for the 5-Part Haematology Analyzer (BC-5140)" and the same should reach the Head Department, School of Physical Education and Sports Sciences, Mahatma Gandhi University on or before. The quotation will be opened on the same day at the office of the School of Physical Education and Sports Sciences, Mahatma Gandhi University.

TERMS AND CONDITIONS

- 1. Confirmation of quotation is decided based on quality, suitability, etc
- 2. The quoted price of reagents should be inclusive of all taxes/freight/installation etc.
- 3. Exemptions for educational institutions if any should be quoted separately.
- 4. Quotation should have a validity of at least three months.
- 5. A brochure/pricelist (Hard Copy) should be submitted along with the quotation.
- Warranty/AMC conditions, nearest service centre details, and necessary demonstrations should be provided.
- 7. The price list must be valid for the entire period of the contract.
- 8. The rate contract is valid for a period of one year from the date of execution of the rate contract. Hence, quote the validity of the rate contract period as one year from the date of execution of the rate contract order, instead of a specified period such as financial

- year or calender year.
- The selected firm must produce a Bank Guarantee in favour of The Principal Investigator, RUSA Project, School of Physical Education and Sports Sciences, Mahatma Gandhi University, Kottayam.
- 10. Orders will be placed periodically based on the lab requirement for each item.
- 11. The payment will be made only on the successful delivery of the product.
- 12. The rate contract can be terminated at any time by giving one month's notice from either side.
- 13. The right to accept or reject the quotation without assigning any reason rests entirely with the undersigned.
- 14. The sealed cover containing the quotation should be superscribed "Quotation for the supply of Reagents for the Haematology Analyzer (BC-5140) " and sent to the undersigned, School of Physical Education and Sports Sciences, Mahatma Gandhi University, Kottayam, to reach on or before 18th March 2025 at 11:00 am.
